# **Notice to Authors**

*Russian Journal of Genetics* publishes the results of complete original studies, theoretical papers, and reviews on a range of topics in modern genetics expected to be of interest to the world genetic community. Short communications are also accepted for publication. The Editorial Board makes decisions on publication after reviewing the submissions on the basis of their scientific value and importance of the studies.

Papers once rejected by the Editorial Board are not reconsidered for publication, and such papers should not be submitted again.

#### **GENERAL**

A letter of presentation of the paper by the research center where the study has been carried out, as well as a copyright transfer agreement (one copy for MAIK "Nauka/Interperiodica" and two copies for Pleiades Publishing, Inc.), should be enclosed with the paper (the text of the agreement can be found at the www.naukaran.ru and www.maik.ru sites). The material should be presented in a clear, concise, and logical way.

Authors should submit 1.5-spaced electronic versions of the new or revised articles; all four margins should be 30 mm. The volume of the manuscript should not exceed **18** typewritten A4 pages for experimental studies and **35** pages for theoretical papers and reviews (including the abstract, tables, list of references, and figure captions), with no more than six figures with a total volume of two A4 pages. Larger papers may be accepted as an exception only after the approval by the Editorial Board. Supplementary Appendix is not published.

The title should be as brief as possible and reflect the main findings. If the title contains the Latin names of the objects of study, they should be unabbreviated and comply with the generally accepted taxonomic nomenclature.

Note that authors should send hard copies of the final versions of revised articles, as well as a copyright transfer agreement by mail, if paper is favorably approved by the reviewer and accepted for publication. ### MANUSCRIPT STRUCTURE

The manuscript structure should be formatted as follows:

1) The Universal Decimal Classification (UDC)

code should be indicated above the title.

2) Title of the paper.

3) List of authors (by initials and surname).

4) List of affiliations and addresses (*unabbreviated*), including the city, postal code, and the e-mail addresses to which proofs and reprints can be sent in electronic form.

If there is more than one affiliation and address, use superscripted letters to indicate the affili- ation of each author. The corresponding author should be indicated with an asterisk. Please indicate, in the list of authors

5) Abstract.

6) Key words.

The paper should be done in accordance with the style file, which you can find at the www.maik.ru sites.

Full names and contact information (including full addresses ) of all authors should be typed on a separate page.

An experimental paper typically has the following sections (Note: Short communications hasn't them) INTRODUCTION, MATERIALS AND METHODS. RESULTS. DISCUSSION. and REFERENCES. Tables and figures should be provided on separate pages at the end of the paper. All figure captions should be presented together on separate pages. The headings of the sections should be typed in all capitals without underlining, on a separate line. Subheadings within the sections should also be typed on a separate line. If the authors wish to acknowledge the assistance/support of persons and/or science foundations or programs in performing the study, the corresponding information should be given under the heading ACKNOWLEDGMENTS after the body of text, before the list of references.

The Editorial Board reserves the right to edit or otherwise change the manuscript in the course of editing, on mutual agreement with the authors.

Figures should contain as little text as possible; individual panels should be marked with lowercase Latin letters or Arabic numerals, which are explained in the figure captions. Each table should have a title reflecting its content and should be presented on a separate page. If there are two or more tables, they are assigned ordinal numbers, which are indicated in Arabic numerals in the page titles. Tables should be compact; in printed form their size should not exceed one journal page. The first reference to each table and each figure in the text should be marked on the page margin as with the word Table or Fig. and its ordinal number in a rectangular frame.

Formulas and symbols should be clear and easily readable. Please pay special attention to superscript and subscript indices.

The references are numbered in the order of their in the text. The references in the text should be cited as numbers in brackets, e.g., [1] or [2-5]. The format of references in the list should be as follows (please pay attention to punctuation and spacing):

- 1. Ivanov, A.S., Paper title, *Journal title*, 1994, vol. 26, no. 1, pp. 15–24.
- 2. Andreeva, S.A., *Book title*, Moscow: Nauka, 1990. (If a special page in the book is referred to, add the page number after a comma, e.g., p. 75.)
- 3. Ivanov, I.I., Dissertation title, *Cand. Sci. (Biol.) Dissertation*, Moscow: Institute name, 1992.

If there are no more than four authors, all of them are indicated in the reference; if there are more than four authors, the first three of them should be listed, followed by *et al*.

If there are references to papers published in *Russian Journal of Genetics*, the English version should be cited, e.g.,

Manuscripts not complying with the above rules will not be considered and will be returned to the authors for revision.

#### INSTRUCTIONS FOR PREPARING ELECTRONIC VERSIONS

#### 1. General

The electronic version of a paper consists of a file containing the text and file(s) containing illustration(s). If the text and illustrations of the paper are in the same file, please additionally present each illustration in a separate file.

## 2. Preparation of the Electronic Version

2.1. The body of text. Manuscripts should be presented in either Microsoft Word or PDF format. Note that lines within a paragraph should not be separated from one another with the paragraph mark (the key Enter).

We plan to extend the list of formats in the future; meanwhile, please use only the above formats.

2.2. *Graphic materials.* We accept both scanned and computer-generated **black-and-white** illustrations in the electronic form.

The following are recommendations for preparing graphic files:

- TIFF format for halftone photos and line drawings is preferable; however, formats JPEG and GIF are also acceptable.

- Use the EPS format for vector pictures/diagrams (made using vector graphics software).

TIFF files should meet the following requirements:

- The resolution of scanned line drawings should be 600 dpi.

- The resolution of scanned halftone photos and other pictures should be no lower than 200 dpi.

When naming graphic files, please make sure that it is clear to which paper they belong and what the ordinal number of the figure is. Each file should contain only one figure.
